CLÁUSULA PRIMEIRA - DO REAJUSTE

A partir de 26/05/2026, o valor mensal devido a título de manutenção e suporte dos serviços previstos no contrato originário será reajustado com base no INPC acumulado nos últimos 12 (doze) meses, compreendidos entre 03/2025 e 02/2026, no percentual de 3,357470%. Em razão do reajuste, o valor mensal atualmente praticado, de R\$ 8.300,00 (oito mil e trezentos reais), passa a ser de R\$ 8.578,67 (oito mil quinhentos e setenta e oito reais e sessenta e sete centavos).

ELECTRONIC RECORD AND SIGNATURE DISCLOSURE

From time to time, FUNDAÇÃO PIO XII (we, us or Company) may be required by law to provide to you certain written notices or disclosures. Getting paper copies

You will have the ability to download and print documents we send to you through the DocuSign system during and immediately after the signing session and, if you elect to create a DocuSign account, you may access the documents for a limited period of time (usually 30 days) after such documents are first sent to you. After such time, if you wish for us to send you paper copies of any such documents from our office to you, you will be charged a \$0.00 per-page fee. Withdrawing your consent

Consequences of changing your mind

If you elect to receive required notices and disclosures only in paper format, it will slow the speed at which we can complete certain steps in transactions with you and delivering services to you because we will need first to send the required notices or disclosures to you in paper format, and then wait until we receive back from you your acknowledgment of your receipt of such paper notices or disclosures. Further, you will no longer be able to use the DocuSign system to receive required notices and consents electronically from us or to sign electronically documents from us.

All notices and disclosures will be sent to you electronically

Unless you tell us otherwise in accordance with the procedures described herein, we will provide electronically to you through the DocuSign system all required notices, disclosures, authorizations, acknowledgements, and other documents that are required to be provided or made available to you during the course of our relationship with you. To reduce the chance of you inadvertently not receiving any notice or disclosure, we prefer to provide all of the required notices and disclosures to you by the same method and to the same address that you have given us.
