1º CONSIDERANDO:

1.1 O contrato de prestação de serviços de análises ambientais pela CONTRATADA a CONTRATANTE conforme proposta LAB PC 167/2025 com descrições no contrato vigente, sendo 12 (Doze) parcelas fixas de R\$ 3.170,75 (três mil, cento e setenta reais e setenta e cinco centavos), totalizando R\$ 38.049,00 (trinta e oito mil e quarenta e nove reais).

1.2 E a inclusão dos serviços de limpeza e desinfecção nos reservatórios de água no período de 12 meses, conforme proposta SA 2605202501, sendo parte integrante deste aditivo, com parcelas fixas de R\$ 478,95 (quatrocentos e setenta e oito reais e noventa e cinco centavos) totalizando R\$ 5.747,36 (cinco mil, setecentos e quarenta e sete reais e trinta e seis centavos).

1.3 Unificando todos os serviços neste aditivo de contrato, no valor total de 12 parcelas fixas de R\$3.649,70 (três mil, seiscentos e quarenta e nove reais e setenta centavos) com o prazo de 10 dias para pagamento após emissão da Nota Fiscal, através de boleto bancário.

1.4 Caso necessário a alteração da data de vencimento e reemissão de novo boleto, por culpa comprovada da contratante, será cobrada uma taxa administrativa no valor de R\$ 3,00 (três reais) por reemissão de boleto.
